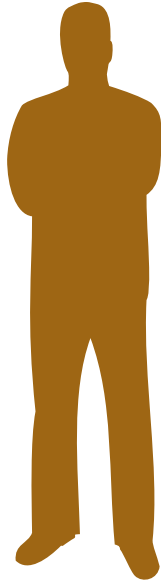

Prayerfully consider these questions:

- "Lord, what is Your destiny for my life and what tools have You given me to accomplish it?"
- "What resources have You blessed me with so that I can now bless others?"
- "How can I further invest in others so that they can be impacted by the love of Jesus?"
- "What changes do I need to make in my life to be passionate about the things You care about?"
- "What are You asking me to sacrifice for Your kingdom?"

God will call different people to give different amounts. What's important is that you understand what He is specifically calling you to do. **It's not about an amount of money; it's about the attitude of your heart.** It is not how much we have that dictates our generosity to God but how much God has of us.

You have an opportunity through your giving to help impact others with the hope of Jesus Christ.

There are no formulas for what you should give. God calls each one of us into a personal relationship with Him, and as you open your heart to His will and His destiny for your life, He will reveal what your commitment should be.

Ask yourself . . .

What am I doing right now to impact others for Jesus? What can I do with my resources, time, and talents to impact others for Jesus in the future?

Am I willing to pray and seek the Lord for His direction? Will I ask God to clear away what might cloud my motivation and judgment so that I can earnestly seek God's will?

Will I invest the time to sit down with my family and have a conversation about what we should do together? Am I willing to hold my family accountable for what God lays on our hearts?

Am I thinking creatively about a sacrifice that represents what I am capable of giving? What can I give up or what purchase am I willing to postpone to further God's kingdom?

Will I continue to seek the Lord during this two-year commitment? This is just the beginning of what God is going to do through your One Life as you honor Him. Experience the joy and real fulfillment in knowing that as you sacrifice you are preparing the way for those whom God is continuing to draw here.

>>> *"Don't become so well-adjusted to your culture that you fit into it without even thinking. Instead, fix your attention on God. You'll be changed from the inside out. Readily recognize what He wants from you, and quickly respond to it. Unlike the culture around you, always dragging you down to its level of immaturity, God brings the best out of you, develops well-formed maturity in you."*

As you prayerfully ask God what He is calling you to give, think about these ways you can be generous and sacrificial.

Income: Give from the overflow of what God has given to you—from income, bonuses, commissions, and tax refunds.

Personal Sacrifice: What are you willing to go without? Perhaps it's time to cut back on an area of your family's budget. If you eliminated one meal out a week and gave the \$50 you'd ordinarily spend, that would add up to a \$3,900 gift over an 18-month period.

Delaying Purchases: Maybe you could postpone buying a big-ticket item, such as a new car or high-definition TV. As you give, you'll experience the joy of learning to be content with the many blessings God has already given to you.

Income-Producing Assets: Interest earned, income from rental properties, or monies from other income-producing assets can be given.

Assets: Perhaps it's time to liquidate some personal or business assets, such as precious metals, jewelry, or real estate, and give the proceeds.

Savings & Investments: Consult your financial advisor regarding how you may be able to give a portion of your assets or retirement plan without significantly affecting future income.
